2.	Date of Inspection of Scrap Items	Scrap items can be inspected at our office during office working hour's i.e. 10:00 a.m. to 4:00 p.m. or can also be contact with Assistant Registrar (General), Guru Nanak Dev University, Amritsar.

3. Terms and Conditions and General Information

- The bidder should be registered with Central/State Pollution Control Board and should have the valid license.
 A copy of the License should be enclosed along with the offer. Non-submission of a valid license will render the tender as invalid and will be rejected.
- 2. Quotations are to be submitted in sealed covers super subscribing the details of quotation and should be submitted within the last date and time specified above.
- 3. Quotations shall be **submitted in the price format** forming part of the enquiry and both on the basis of price per unit and price per kilogram (Kg).
- 4. GST to be paid extra, as applicable, at the time of taking out the materials.
- 5. The sale shall be on "as is where is basis."
- 6. It is the responsibility of the bidder to assess the items properly before quoting. No further claims will entertained after opening of the bids.

- 7. Bids received within the due date only will be entertained.
- 8. The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bid.
- 9. The Quotations shall be written legibly and the free from erasing and over-writing. Corrections, if any, should be duly attested by the authorized signatory. Rates should be written both in words and in figures.
- 10. Bidders cannot withdraw their offer once it is submitted.
- 11. No enquiry of bidder shall be entertained once the material of lifted by them.
- 12. All labour, tools and equipment for loading the items from GNDU campus, Amritsar, site to buyer's trucks with all leads, lifts, etc., shall be at the cost of the buyer.
