- 3. The rent of the premises shall enhance by 5% per annum over and above the existing lease rent.
- 4. Every allottee shall have to furnish an **irrevocable bank guarantee** for each premises, covering the lease rent & taxes thereon, <u>of atleast 12 months</u>, operative for 9 years, <u>alongwith the **security amount/deposit**</u> equivalent to the lease rent & taxes thereon <u>of 6 months</u>.
- 5. All the legal expenses stamp duty, registration charges etc. of whatsoever nature, required at the time of execution of lease deeds, shall be borne exclusively by the lessees concerned.
