The Department of Education, Guru Nanak Dev University, Amritsar and the Spring Dale Senior School, Fatehgarh Churian Road, Amritsar, Punjab collectively "the Parties", enter into this Memorandum of Understanding (hereafter "Agreement") and have mutually agreed upon the terms and conditions of our relationship as outlined below:

The aim of this MoU is to motivate, train and engage Special School students and teachers in various initiatives/activities that are currently being organised by RCI for its special students and faculty to enhance their skills. WHEREAS, RCI has initiated several schemes for benefits of faculty and students, and manages various portals to provide facilities across the country.

OBJECTIVES: The Objectives of the MoU are as follows:

1) To enable both parties to understand the concept of disability, inclusive education, the discipline of education and mainstreaming of the differently-abled children.

- 2) To make both parties understand how differently-abled children learn and develop, how they differ in their approaches to learning due to their disabilities and create learning opportunities that are beneficial to their diverse learning needs and context.
- 3) To develop the skills of students of B.Ed. (Special Education) to plan special learning experiences in both curricular and co-curricular activities in and outside the classroom which are based on the existing learning difficulties faced by the differently-abled persons.
- 4) To enable the students of B.Ed. (Special Education) to understand and use formal and informal assessment strategies to identify, evaluate and educate Children with Special Needs (CWSN) as well as DIVYANGJAN and work towards their rehabilitation in the society.
- 5) To identify the speciality of Children with Special Needs (CWSN) and develop confidence in them to realise their potential and abilities to live with self-respect, dignity and freedom.
- 6) To develop skills and competencies of students of B.Ed. (Special Education) to cater to the needs of the children with Intellectual Disability, Autism Spectrum Disorder (ASD), Attention Deficit Hyperactivity Disorder (ADHD), Cerebral Palsy, Down Syndrome, Deafblindness, Visual Impairment, Hearing Impairment and disabilities in general and in a special class setting in particular in cognitive, affective and skill domains.
- 7) To equip trainees with various techniques of teaching children with Intellectual Disability, Autism Spectrum Disorder (ASD), Attention Deficit Hyperactivity Disorder (ADHD), Cerebral Palsy, Down Syndrome, Deafblindness, Visual Impairment, Hearing Impairment associated with additional disabilities in a special and inclusive setup.
- 8) To develop the Teaching Learning Materials (TLM), Supplementary Aids and Services, and for this both parties should maintain confidentiality.
- 9) To provide a platform to the students of B.Ed. (Special Education) Department of Education, Guru Nanak Dev University to integrate and experiment the various ICT and assistive technologies.
- 10) To develop a learning environment for the students of B.Ed. (Special Education) to increase their capabilities and potentialities.
- 11) To enable both the parties to understand the concept of AUGMENTED REALITY and use it as a teaching technique for the Children with Special Needs to develop their Activities of daily living skills, supporting learning, increasing comfort and confidence and improving physical, navigation skills and social skills.

#### CONFIDENTIALITY:

The parties may, from time to time, execute addenda or modifications to this MoU to incorporate such additional scope of collaborations or discussions.

#### NON-EXCLUSIVE:

The Parties acknowledge and agree that the areas of collaboration under this MoU are being undertaken on a non-exclusive basis and either Party shall be free to enter into or consummate transactions similar to the areas of collaboration with other parties in India or elsewhere maintaining the confidentiality of the parties.

#### TEACHING:

The parties acknowledge and agree that they identify the ways to enhance pedagogical competencies to teach children with special needs. Both parties shall integrate ICT and various assistive technologies in teaching.

#### INTERNSHIP OF B.Ed. (Special Education) STUDENTS OF GNDU:

- B.Ed. (Special Education) students for internship phase will be allotted to the special school.
- The school will assist the university in evaluation of interns' performance.
- The school will allow the interns to carry out classroom observations.
- The university and the school will work together to determine potential policy to improve outcomes.
- The partnership will provide mentoring and supervision for interns throughout their internship: including both the host principal and a university supervisor.

#### Note:

The School will provide the placement opportunities to the B.Ed. (Special Education) and B.Sc. ECCE (Hons.) students.

#### PROFESSIONAL DEVELOPMENT:

Department of Education will assist the school:

- By identifying professional associations and conferences.

- Both parties will collaboratively organise different Workshops/ Seminars/ Conferences for the Continuous Professional Development (CPD) and Continuing Rehabilitation Education (CRE) programmes of faculty members.

#### **COMPLIANCES:**

Each Party agrees to perform its activities in compliance with all applicable statutes and regulations that are in force at that time or as revised from time to time.

#### TERM AND TERMINATION:

The term of this MoU shall be for a period of five years from the date of execution, unless terminated earlier by a written notice of thirty (30) days by EITHER Party, seeking such termination to the other Party, hereto. The party seeking termination will not be bound to justify the reasons of termination to other party, whatsoever. However, all commitments and obligations till the date of termination will be honoured by both the parties.
