

MEMORANDUM OF UNDERSTANDING

The term of MOU already existing between Guru Nanak Dev University, Amritsar and Indian Institute of Integrative Medicine, Jammu (formerly Regional Research Laboratory, Jammu) expired on 9.10.2014. It is hereby being renewed as such.


In order to share the facilities and expertise available and to explore, extend and strengthen the functional collaboration between the two institutions, the Indian Institute of Integrative Medicine, Jammu and Guru Nanak Dev University, Amritsar.

1. Research students working in Indian Institute of Integrative Medicine, Jammu may register for Ph.D Degree to be awarded by Guru Nanak Dev University, Amritsar. There will be Supervisor from Indian Institute of Integrative Medicine, Jammu (not be below the level of Scientist 'C') and a Supervisor from Guru Nanak Dev University, Amritsar.
2. Ph.D students working at Guru Nanak Dev University, Amritsar would be permitted to carryout part of their research work at Indian Institute of Integrative Medicine, Jammu and if needed, a scientist of Indian Institute of Integrative Medicine, Jammu not below the level of scientists 'C' may be a Supervisor. Indian Institute of Integrative Medicine, Jammu will provide the necessary laboratory facilities to such students as may be recommended by Guru Nanak Dev University.
3. Indian Institute of Integrative Medicine, Jammu will provide short term training to the students and faculty members of Guru Nanak Dev University, Amritsar in the areas of core competence of the Indian Institute of Integrative Medicine, Jammu.


4. The faculty of Guru Nanak Dev University, Amritsar and scientists of Indian Institute of Integrative Medicine, Jammu may apply for collaborative projects jointly to national and international funding agencies within the regulations of respective institutions and will share the facilities at their respective institutes.
5. The research publications out the jointly supervised work will be authored jointly by the student and the supervisors from both of the institutions. Any patent filed out of such a work will be credited jointly to both of the institutions.
6. This MOU is valid for a period of five year subject to further extension on mutually agreed terms and conditions. Any mid-course change/alteration/termination mutually agreed upon by both the parties shall be valid.
