MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is executed on the Nineteenth day of December, 2017, between Guru Nanak Dev University, functioning under the provisions of Universities Act and located in Amritsar-143005, represented by its Dean Academic Affairs

AND

Sri Guru Ram Das Institute of Medical Sciences & Research, Amritsar, affiliated to Sri Guru Ram Das University of Health Sciences, Amritsar, the premier health care Institute having state of the art Advanced Cancer Centre, located at Mehta Road, Valla, Sri Amritsar, represented by Dean of University.

Article 1: Purpose of the Agreement

- i. Guru Nanak Dev University (hereinafter called GNDU), established in 1969, is a reputed institute of higher learning in the country, serving the cause of National Development by offering tertiary education and conducting basic and applied research in various disciplines.
- ii. Sri Guru Ramdas Institute of Medical Sciences & Research, Sri Amritsar (hereinafter called SGRDIMSR), is a modern Health Care Institute, equipped with ultra modern state-of-the-art facilities and is implementing latest treatment techniques in the service of human health care. It is in the process of establishing front-line research facilities and is offering extensive teaching programs in the areas of Medical Sciences.
- iii. Collaboration for teaching of relevant portions of the courses and for conducting structured residency (Internship) / field training is essential for many Departments of GNDU where course work are related to Medical Sciences and for this purpose a MoU with an established institution like SGRDIMSR is envisioned.
- iv. GNDU and SGRDIMSR have mutually agreed to collaborate in the teaching, conducting practicals in relevant courses and for providing required residency / field training program for various courses related to Medical Sciences.

Article 2: Implementation of the MoU

- i. The work related to the academic instructions required for various Medical Science related courses will be conducted in relevant Departments of GNDU / SGRDIMSR. The payment to the instructors will be made on lecture basis as per Rules of the GNDU in this regard, prevailing at that time, as modified from time to time.
- ii. SGRDIMSR agrees to extend its facilities for conducting the practical exams as well as residency / field training / workshops etc. free of cost.

Article 3: Restrictions and Limitations

- i. This agreement is not to be construed as contract in law, creating legal relationship between the two institutions. Instead, it is formulated in the interest of generating human resource in the field of Medical Sciences to facilitate and develop mutually beneficial synergistic academic activity.
- ii. In the spirit of this agreement, each institution is considered as principle. Neither institution is authorized or empowered to act as agent for the others for any purpose or shall enter on behalf of the others into any contract or representation on any matter. None of the two institutions shall be bound by the acts or conduct of the other.

Article 4: Validity of the Agreement

- i. This agreement between the GNDU and SGRDIMSR is valid for as per mutual agreement.
- ii. For incorporating any modification, changes and amendments to this Memorandum of Understanding the written consent from both the Institutions— GNDU and SGRDIMSR shall be mandatory.
