12. Technical Bid :- List of documents to be submitted as per form T) online only (ii) Price Bid/ Financial Bid online only as per Proforma).
13. Incomplete Tenders/ tenders without required documents of technical bid, tender fee & earnest money are liable to be rejected.

In case the lowest bidder commits mistakes or fails to comply with the terms and conditions, the matter will be considered by committee constituted by the competent authority for appropriate action viz forfeiting of EMD, Blacklisting the firm or any other action deemed fit by the committee and the decision of committee will be binding on the L-1 firm/lowest bidder.
