### **Statement of the Vice Chancellor**

The Vice-Chancellor informed the Syndicate that eight shooters from Guru Nanak Dev University (GNDU) won five individual gold medals, six team gold medals, two silver medals, and one bronze medal while representing India at the 16th Asian Shooting Championship held in Kazakhstan. It is a matter of great pride that GNDU was appointed as the Nodal University for the World University Games held in Germany from 16th to 27th July 2025.

The Vice-Chancellor apprised the Syndicate of the direct recruitment of over 12 faculty members across various departments, and the promotion of 70 faculty members under the Career Advancement Scheme. Additionally, direct recruitment and promotions were carried out for several non-teaching positions.

The Vice-Chancellor informed the Syndicate that student admissions increased from 5,513 in the previous academic session to 6,197 in the academic session 2025–26.

The Vice-Chancellor also reported on the extension of research facilities to affiliated colleges, accompanied by necessary amendments in University ordinances to facilitate this initiative.

It was further informed that arrears related to the Pay Commission have been disbursed to the pensioners.

A Relief Fund has been established by the teaching, non-teaching, and officers' associations of the University to assist those affected by the recent floods.

Over the past three months, 78 students from various departments have been placed in national and multinational companies, with the highest annual package being ₹13.78 lakh.

Three start-ups nurtured by GNDU secured top honors at the Future Tycoons programme organized by the District Administration.

Guru Nanak Dev University has become the first government university in northern India to launch the E-Sanad Portal, enabling secure and fast online document verification.

The Vice-Chancellor also informed the Syndicate about several recent MoUs and agreements, including:

- A Centre of Excellence in Urban Planning and Design,
- A Material Transfer Agreement with Sweden's Karolinska Institute — a globally renowned medical research institution and the body responsible for awarding the Nobel Prize in Physiology or Medicine,
- Two MoUs with ArogayaCIBioD Healthcare Foundation and Nirogya Life Line Foundation, both operating under PGIMER, Chandigarh, to foster collaboration in knowledge sharing, research, and capacity building.

The Indo-Norwegian Cultural Forum has conferred the Premchand Award on Prof. Sunil Kumar from the Department of Hindi, GNDU.


GNDU hosted a five-day workshop on 5G Technology, and a State-of-the-Art 5G Lab has been established in the Department of Electronics Technology in collaboration with the

Department of Telecommunication, Government of India. This facility will serve as a hub for research, innovation, and skill development in the field of 5G communications.

It was also highlighted that GNDU had the honour of participating in the 80th Science Summit of the United Nations General Assembly, marking another milestone in its international engagement.

Lastly, the Golden Jubilee Centre for Entrepreneurship and Innovation, in collaboration with PUM Netherlands, conducted a 'Train the Trainer' programme aimed at strengthening the regional entrepreneurial ecosystem. The initiative was designed to equip educators with advanced knowledge and training methodologies in entrepreneurship.
