

- 2 The rates quoted should be nett inclusive of Octroi, Excise Duty, Packing & Forwarding, Freight, Local carriage etc on F.O.R. Guru Nanak Dev University Campus, Amritsar.
- 3 GST, as applicable at the time of supply, shall be payable extra.
- 4 Words "Quotation due on 20.01.2026 for Purchase of Wooden Chair and Wooden Reading Table for Bhai Gurdas Library" may be noted on the top of the envelop.
- 5 The undersigned does not bind himself to accept the lowest or any quotation and reserves to himself the right of accepting the whole or part of the quotation and the quotee shall be bound to perform the same at the quoted rates.
- 6 Head, Engineering Department reserves the right to reject or accept any quotation or all quotations.
- 7 The bidder/supplier/Firm must have a valid GST registration number.
- 8 Quantities can be increased or decreased as per requirement.
- 9 Product shall be got approved from the Competent Authority/Engineer-in-charge before supplying the material.
- 10 If the due date falls on a holiday, then the quotation will be received on the next working day.
- 11 Variation in size & shape shall be applicable as per specification/ISI code.
- 12 CONDITIONAL QUOTATIONS SHALL NOT BE ENTERTAINED.

- 13 Before filling his tender/Quotation the contractor shall visit the site/store and satisfy himself as to the conditions prevalent there especially regarding accessibility to the site, nature and extent of the ground, working conditions, stacking of materials installation of tools and plants etc., accommodation and movement of labour, supply of water and power for satisfactory completion of the works contract. No claim, whatsoever on such accounts shall be entertained by the department in any circumstances.
- 14 No advance payment shall be made. 100% of the payment will be made after supply the material to the satisfaction of the competent authority.
- 15 The warranty period should be clearly mentioned on the warranty certificate/document.
- 16 Delay / loss in postal transit or due to any other reasons will not be University's responsibility.
- 17 The University will not responsible for accidental opening of the covers that are not properly superscribed and sealed before the time scheduled for opening.
- 18 Authorized signatory should sign on all the pages. Bids/Quotation without authorized signatures or seal of the firm shall be rejected.
- 19 All bidders/Quotees are legally bound to comply with the provisions/clauess/conditions of the standard bidding document/ F1 Form of the GNDU, failing which the action as the university may find fit, shall be taken against the bidders/Quotees.
- 20 In case of dispute, legal matter, if any shall be subjected to Amritsar Jurisdiction only.
- 21 The Delivery of Material shall be made within time period as mentioned above from issue of supply order, failing which the order can be withdrawn.
- 22 The offer shall remain open for acceptance for a period of NINETY days from the date of opening of the quotation.
- 23 In case the lowest bidder commits mistakes or fails to comply with the terms and conditions, or fails to supply the product as per specification, the matter will be considered by committee constituted by the competent authority for appropriate action viz forfeiting of EMD, Blacklisted the firm or any other action deemed fit by the committee and the decision of committee will be binding on the L-1 firm/ lowest bidder.
- 24 The University reserves the rights to cancel the order if it is found at any later stage that the supply is not being made as per specification & satisfaction and the payment shall not be made for the received goods.
25. In case of any mishappening /damage to material and supplies during the carriage of goods the supplier has to replace it with new supplies immediately at his own risk. The Guru Nanak Dev University, Amritsar will not be liable to any type of losses in any form.




