The above positions are co-terminus with the RUSA 2.0 scheme. Last date for receiving the application is 13/01/2021.

Applicant's Eligibility

The candidates must have a doctorate degree in the relevant subject preferably with published research work to their credit (ii) Only Ph.D. awarded unemployed candidates will be eligible for the award of Post-doctoral Fellowships (iii) The upper

age limit for applicants is 35 years, relaxation in age for SC/ST/OBC/Women candidates applicable as per Government of India Norms.

****Preference will be given to candidates having experience in the relevant research area.***
