- 3. In case the supply order is not completed within the stipulated period by the bidder or if the bidder fails to comply with the terms and conditions, then the matter will be considered for imposing a penalty of 5 % on the total amount of the bill for the concerned job.
- 4. **Computers, Printers and UPS's** supplied by the firm should be as per specifications mentioned in the tender document. Any deviation from Technical Specification is not allowed and leads rejection of bid. Sub-standard material will not be accepted at all. Firms should supply all items strictly according to specified technical specification.
- 5. The firm should have an annual turnover of atleast Rs.50 Lac per year for the three financial years (2021-2022, 2022-2023, 2023-2024). Attach certificate issued by the chartered accountant as proof along with Technical Bid & copies of Income Tax return for three Years (2022-2023, 2023-2024, 2024-2025)
- 6. The firm must have work experience related to Computers, Printers and UPS's in supplying material to the Govt. and private sector. The bidder is required to submit copies of bills for year 2023-2024 only.
- 7. The Rates quoted by the Bidder for Computers, Printers and UPS's specified in Sr. No. A., Sr No. B, Sr. No. C Sr. No. D and Sr. No. E, the L-1 bidder will be decided by the committee on the basis of lowest price quoted for each item i.e for Computers, Printers and UPS's, separately.
- 8. The Tender should contain full details indicating the make, model and other mentioned specifications of the **Computers, Printers and UPS's** alongwith the pamphlets.
- 9. The quantity of Computers, Printers, UPS's may be increased / decreased.
