3. The institutional discount should be mentioned clearly.
4. The Quotations shall be written legibly and free from erasing and over-writing. Corrections, if any, should be duly attested by authorized signatory.
5. Bids received within the due date only will be entertained.
6. The quotation should be valid for a period of 60 days for acceptance from the date of opening of the bids
7. Bidders cannot withdraw their offer once it is submitted.
8. The vender may quote the items, which meets the requirements and specification along with the layout, make, model, material specifications, dimensions, brochures, photo catalogues of items along the quotation.
