Sir/Madam

The UGC vide letter No. F.25-22018(PS/Misc/VIP/MHRD) PTI dated 10.09.2018 has informed that option for fixation of pay on the date of promotion is allowed. A teacher can opt either to get his pay fixed on the date of promotion or from the date of his/her increment in the old post.

The above said UGC letter has been adopted by the Syndicate in its meeting held on 15.10.2018 vide Para 2.26.

The detail regarding giving option is that in case a teacher opts to get his pay fixed from his date of next increment, then, on date of promotion, pay in the pay band shall continue unchanged, but the grade pay of the higher post will be granted. Further refixation will be done on the date of his next increment i.e. 1st July. On that day he will be granted two increments, one annual increment and the second on account of promotion. While computing these two increments, basic pay prior to the date of promotion shall be taken into account.

If date of promotion between 2nd July to 1st Jan

For example

If a teacher has been promoted on 03.08.2014 and has given option to grant him benefits of increment on the date of promotion, his pay will be fixed as under:

D.O.P. 03.08.2014

Benefit of one increment 03.08.2014 with AGP

Next increment 01.07.2015

If date of promotion between Jan to June

For example

If a teacher has been promoted on 03.02.2015 then he has two options
